For full access to the back issue archive of a particular subscribed journal a subscriber must maintain a current subscription. If a subscription is cancelled the subscriber will only maintain perpetual access to the years / volumes they have subscribed to and paid for. 3. Online and print + online subscription access will only commence once a signed site licence is returned to JNP.
